2. Mayor's report.

5. Resolution No. 2015-59:

WHEREAS, an emergency repair was necessary to the air conditioning system at the Village's 500 Chestnut Ridge Road building.

RESOLVED, that the Village Clerk is authorized to complete an agreement with A&I Cooling and Heating, Inc., in the amount of \$2,675.00 to effectuate the emergency repairs.

6. Resolution No. 2015-60:

Resolution approving a water line and sprinkler repairs in the Village Park in the amount of \$1,207.00.

WHEREAS, repair work is necessary to the sprinkler system and water fountain system at the Village Park, and

WHEREAS, the Village Clerk received quotes for the work in accord with the Village's Procurement Policy.

RESOLVED that the Village Clerk is authorized to complete an agreement with Pro-Cut Lawns and Landscaping in the amount of \$1,207.00 to effectuate the repairs.

RESOLVED that a Public Hearing to amend Local Law No. 13 of 1987, entitled "Vehicle and Traffic Law of the Village of Chestnut Ridge" with respect to truck weight limits on local roads is scheduled for July 16, 2015 at 8:00 pm.

8. Resolution No. 2015-62:

RESOLVED that the following Attendance Policy for Appointed Officials for the Village of Chestnut Ridge is hereby adopted:

ATTENDANCE POLICY FOR APPOINTED OFFICIALS FOR THE VILLAGE CHESTNUT RIDGE

WHEREAS, consistent attendance by appointed officials is imperative for the proper functioning of municipal Boards and Commissions, and

WHEREAS, the Mayor of the Village of Chestnut Ridge and/or the Board of Trustees appoint residents to serve on various Boards and Commissions necessary to implement municipal functions set forth in New York State Village Law, and

WHEREAS, the Board of Trustees is desirous of implementing and attendance policy for appointed officials so as to encourage consistent attendance by members of such Board and Commissions.

NOW THEREFORE BE IT RESOLVED, that each and every appointed member of a Board or Commission of the Village of Chestnut Ridge shall be required to make their best and reasonable effort to attend each scheduled meeting of the Board or Commission to which such member has been appointed.

BE IT FURTHER RESOLVED that in the event that an appointed member of a Board or Commission of the Village of Chestnut Ridge is unable to attend a meeting, that such member shall notify the secretary to such Board or Commission of that he or she is unable to attend such meeting at least 48 hours in advance of the meeting.

BE IT FURTHER RESOLVED that should an appointed member of a Board or Commission of the Village of Chestnut Ridge fail to attend forty (40%) of conducted meeting of their Board or Commission in any official Village year, that the Mayor, in consultation with the Board of Trustees, shall have the power to:

- (i) Reprimand such member, and/or
- (ii) Withhold the monetary stipend for such missed meetings, and/or
- (iii) Remove such member from the Board or Commission.

None of the aforesaid actions shall be undertaken or imposed without providing the member an opportunity to be heard; including but not limited to a public hearing in the event that a public hearing is requested by such member, so that such member may be afforded a full and fair opportunity to refute the imposition of any sanction as referenced hereinabove.

BE IT FURTHER RESOLVED that to the extent that the provisions of this Village Policy conflict with any other law that the provisions of this Policy are intended to supersede such provision of law to the extent that the same is authorized by law.

This policy is effective for the official year 2015 - 2016, and will be reviewed annually.

Resolution to retain a contractor to perform lawn maintenance at 2 Matthew Drive, and to add the cost to the Village tax levy on the property.

WHEREAS, the owners of 2 Matthews Drive have been served with a notice of a property maintenance violation at 2 Matthew Drive, and

WHEREAS, the owners have failed to respond to a summons to appear in the Justice Court to address the property maintenance violation, and

WHEREAS, the Village Board of Trustees finds that the continuing lack of maintenance at the premises constitutes a public nuisance adversely affecting the adjoining neighborhood, and

WHEREAS, a Public Hearing on the issue of retaining a contractor to perform lawn maintenance on 2 Matthew Drive was held on August 14, 2014, and

WHEREAS, the problem continues to exist.

THEREFORE BE IT RESOLVED that the Village Clerk is directed to obtain quotes pursuant to the Village's Procurement Policy for lawn maintenance at 2 Matthew Drive, and upon expenditure of funds to provide the amount spent to the Village Treasurer who shall assess the cost to the Village tax levy on the property.

•Trustee Cohen: Asked does this pertain to only one cut?

• Attorney Sevastian: It will cover the season.

Trustee Cohen: If grass grows 10" high we do not have to pass another resolution.

Mayor Presti: So the clarification is this is an on going resolution for the rest of the growing season. It will cover 2 Matthew Drive; so that any expense will be attached for the period ending Fall, 2015.

Trustee Cohen:
