Key Recommendations of the 2020 Village of Chestnut Ridge Comprehensive Plan

1. The Conceptual Land Use Plan recommends adding Planned Industry(PI) uses to lands currently zoned Laboratory Office (LO) in the Red Schoolhouse Road corridor area, to create a new PILO zoning district.
2. A small increase in area for the Regional Shopping Zone is proposed for the west side of Red Schoolhouse Road at the Montvale/New Jersey boundary.
3. A floating zone to allow Planned Unit Development with a mix of commercial and residential uses at a density of up to 7 units per gross acre is proposed for areas within one-half mile of the Garden State Parkway Extension/NY Thruway interchange, on sites with a minimum of 25 acres. A separate SEQRA process with an Environmental Impact Statement is underway to study the potential impacts from a proposed PUD floating zone.
4. New development in the Red Schoolhouse Corridor will be required to contribute to transportation improvements and sidewalk construction through the site plan approval and SEQR process.
5. Current development proposals in the Red Schoolhouse Road Corridor area are now participating in a joint traffic study to identify needed traffic improvements.
6. Zoning Districts in developed residential areas are recommended to be adjusted to reflect existing patterns of lot sizes. 58% of residential lots in the Village are smaller than the minimum lot requirement for the district in which they are located. A new zoning maps is proposed with the following changes as summarized below:
 - Create new zones
 - R-10, with minimum lot area of 10,000 sf.
 - R-15-1F, with minimum lot area of 15,000 sf, but differing from current R-15 with limitation to Single-Family homes only
 - R-20, with minimum lot area of 20,000 sf.
 - PILO, which would be a combination of the existing PI (Planned Industry) and LO (Laboratory Office) Zoning Districts. PILO would also allow Assisted Living and Warehousing Uses.
 - Change current R-35 zone west of Chestnut Ridge Road to R-25,
 - Change RR-50 zone in Lancaster Drive/Ackertown Rd./Karow Ct./Windsor Terr./Menocker Road Area to R-25.
 - Change LO zones to PILO (a combination of Planned Industry and Laboratory Office Zones), except when adjacent to R-15
 - Change R-15 to R-10, in portion west of Chestnut Ridge Road
 - Adjust R-35 Boundaries near Margetts Road and Hungry Hollow and Eagle Street, and along Summit Road (north side).
 - Change R-25 to R-15-1F (with one family houses only) in Dexter Park area (Balmoral Dr./Renfrew Rd./Carlisle Rd./Ross Ave./Lomond Ave./Aberdeen Ave./Perth Ave.)
 - Change R-25 to R-20 north of Dexter Park (Samuel Rd./Brookview Blvd./Lilian Dr./Castle Dr./Cheryl St.)
7. The existing Green Meadow School/Threefold Foundation campus is located in the RR-50 zoning District, and it does not conform to the district's standards. Almost any land use activity undertaken by the Green Meadow school requires variances. The Plan recommends creation of

a floating zone which may “land” or be utilized only in RR-50 which allows education campus/philanthropic uses/group quarters/accessory housing/agriculture to be designed in a master plan in a unified development. It is anticipated that the Threefold Foundation would petition the Village Board to adopt such a floating zone within three years of the adoption of the Comprehensive Plan.

The plan identifies areas of the community in the Red Schoolhouse Corridor near the Garden State Parkway interchange, where Planned Unit Developments with mixed use of higher density housing and commercial uses may be established. The plan also recommends the addition of Planned Industrial Uses to the existing zoning districts allowing Professional Office Uses. The plan also recommends the adoption of a floating zone to allow accessory housing and commercial uses for educational uses established in the RR-50 district.

The potential for new construction may lead to the above impacts, and should be analyzed in an Environmental Impact Statement. The uses and intensity of construction proposed will be compared to what is currently permitted in the Village by its existing codes.
