



SCHEDULE OF FEES AND CHARGES

The following shall constitute, and each applicant shall pay, to the Village of Chestnut Ridge, the following fees and charges for the purposes hereinafter enumerated:

1) SUBDIVISIONS:

- (1) Sketch Plat \$500.00 plus \$150.00 per lot, plus \$250.00 per meeting for each appearance after the first meeting on the application.
- (2) Preliminary Plat \$500.00 plus \$100.00 per lot, plus \$250.00 per meeting each appearance after the first meeting on the application.
- (3) Final Plat \$500.00 plus \$100.00 per lot, plus \$250.00 per meeting for each appearance after the first meeting on the application. The applicant shall also pay the actual cost of reproduction.

2) SITE DEVELOPMENT PLAN:

- (1) Preliminary Site Development Plan-\$400.00 and, in addition thereto, the following additional fees for the specific purposes enumerated:
 - (a) Senior Citizen and Handicapped Housing Developments: \$20.00 per unit
 - (b) All other uses: \$35.00 per actual parking space provided on site plan.
 - (c) \$250.00 for each subsequent appearance.
- (2) Final Site Development Plan-\$400.00 and, in addition thereto, the following additional fees for the specific purposes enumerated:
 - (a) Senior Citizen and Handicapped Housing Developments: \$20.00 per unit
 - (b) All other uses: \$35.00 per actual parking space provided on site plan.
 - (c) \$250.00 for each appearance.
- (3) CDRC Appearance (no pending Planning Board application): \$250.00
- (4) Planning Board Application for Informal Discussion: \$250.00

- 3) INSPECTIONS AFTERSITE DEVELOPMENT PLAN AND/OR SUBDIVISION APPROVALS:
- (1) For inspection of the required on and off-site improvements to ensure their satisfactory completion the applicant shall pay the following:
 - (a) Six (6%) per cent of the estimated costs of all site improvements, excluding buildings.
 - (b) There shall be a minimum fee of \$150.00 for any subdivision or site plan inspection whether or not there are any public improvements required.
- 4) RECREATION FEE (IN LIEU OF LAND):
- (1) A fee of \$5,000.00 per dwelling unit.
- 5) CONDITIONAL OR SPECIAL PERMIT USES:
- (1) Professional Office or Home occupation: \$250.00
 - (2) For all other Conditional Use or Special Permit applications: \$375.00
 - (3) Flood Plain or Floodway applications: \$300.00
- 6) RE-ZONING:
- (1) \$350.00 for first acre or fraction thereof, \$150.00 per acre for each additional acre or fraction thereof.
- 7) PLANNING BOARD APPEARANCE, INCLUDING CDRC:
- (1) \$250.00 for each appearance
- 8) ZONING BOARD OF APPEALS:
- (1) For actions involving existing single-family residence: \$250.00.
 - (2) All others, excluding subdivisions: \$400.00
 - (3) Subdivision: \$350.00 per lot.
 - (4) Appearance Fee for each appearance \$250.00
- 9) ARCHITECTURAL REVIEW BOARD:
- (1) New Construction: \$250.00 (includes workshop & meeting)
\$250.00 each additional appearance
 - (2) Additions and renovations to existing structure: \$250.00.

(3) Appearance Fee for each appearance \$250.00

10) ESCROW ACCOUNTS FOR LAND USE APPLICATIONS

(1) Planning Board

- (a) \$5,000.00 to be replenished at the direction of the Planning Board or Village Treasurer
- (b) Informal/CDRC \$5,000.00 to be replenished at the direction of the Planning Board or Village Treasurer.

(2) Zoning Board of Appeals (ZBA)

- (a) \$1,500.00 to be replenished at the direction of the ZBA or Village Treasurer

(3) Architectural Review Board (ARB)

- (a) \$1,500.00 to be replenished at the direction of the ARB or Village Treasurer

11) CLEARING, FILLING AND EXCAVATION PERMITS:

- (1) \$100.00 for first 1,000 square feet of affected area or part thereof, plus \$50.00 for each additional 1,000 square feet of affected area or part thereof.
- (2) Affected area to be determined by Village Engineering Consultant.

12) WETLAND PERMIT:

- (1) \$100.00 for the first 1,000 square feet of affected area or part thereof, plus \$50.00 for each additional 1,000 square feet of affected area or part thereof.
- (2) Affected area to be determined by Village Engineering Consultant.

13) ROAD OPENING PERMIT:

- (1) New road or street connection: \$200.00.
- (2) Opening of street paved within 12-month period prior to application: \$1,000.00 plus 50 cents per square foot.
- (3) All other applications: \$300.00.
- (4) Each Inspection: \$100.00.

14) SIGN PERMIT (COMMERCIAL):

- (1) Sign Plan Application (Permanent or Temporary Signs): \$150.00.

(2) Renewal Application for Temporary Signs: \$50.00

15) TEMPORARY POLITICAL SIGNS

- (1) \$100.00 check for the organization to be cashed if signs are not promptly removed (within 3 business days) after the event.

16) BUILDING PERMIT (EXCLUSIVE OF RE-INSPECTIONS):

(1) New one or two-family dwellings:

- (a) \$200.00 for first \$1,000.00 of construction cost plus \$11.00 for each additional \$1,000.00 or fraction thereof.
- (b) Certificate of Occupancy: \$100.00 Payable at time of issuance of Building Permit.

(2) Alterations, Repairs, Additions, Accessory Buildings or Structures, Demolition, Plumbing, etc. affecting one or two-family dwellings:

- (a) First \$1,000.00 of construction cost: \$100.00 plus \$9.00 for each additional \$1,000.00 or fraction thereof.
- (b) Certificate of Occupancy: \$50.00 Payable at time of issuance of Building Permit.

(3) New Construction or Alterations, Repairs, Additions, Accessory Buildings, or Structures, Demolition, Plumbing, etc. for other than one and two-family dwellings:

- (a) First \$25,000 of construction cost: \$300.00.
- (b) Next \$25,000 of construction cost: \$300.00.
- (c) Next \$50,000 of construction cost: \$400.00.
- (d) Next \$50,000 of construction cost: \$500.00 plus \$9.00 for each additional \$1,000.00, or fraction thereof.

(4) Certificate of Occupancy or Certificate of Use: \$100.00 payable at time of issuance of Building Permit

(5) Engineering Escrow

- (a) New Homes \$1,500.00
- (b) Additions, Pools, etc. \$1,000.00
- (c)

17) RE-INSPECTION FEE (for re-inspections required after construction work has been disapproved).

- (1) For the First Such Re-inspection: \$75.00
- (2) For Each Subsequent Re-Inspection: \$100.00

18) FIRE INSPECTION:

- (1) Places of Assembly:
 - (a) Up to 50 persons: \$75.00
 - (b) 51 to 100 persons: \$100.00
 - (c) 101-300 persons: \$125.00
 - (d) 301 or more: \$.50/person
- (2) Other Non-Residential Facilities (size of total facility):
 - (a) Up to 5,000 square feet: \$75.00
 - (b) 5,001 to 10,000 square feet: \$150.00
 - (c) 10,001 to 25,000 square feet: \$500.00
 - (d) 25,001 to 50,000 square feet: \$750.00
 - (e) 50,001 to 75,000 square feet: \$1,000.00
 - (f) 75,001 square feet or more: \$1,500.00
- (3) Hotels and Other Transient Occupancy (Group R-1):
 - (a) Up to 10 rooms: \$100.00
 - (b) Each Additional Room over 10: \$15.00
- (4) Residential Permanent Occupancy (Group R-2)
 - (a) Up to 3 Living/Sleeping Units: \$40.00
 - (b) Each Additional Living/Sleeping Units: \$10.00
- (5) Residential Care/Assisted Living Facilities (Group R-4):
 - (a) Up to 10 beds: \$100.00
 - (b) Each Additional Bed: \$5.00
- (6) Re-Inspection Fee:
 - (a) \$100.00 for each re-inspection after original inspection, but not to exceed the original inspection fee for each re-inspection.
- (7) Certificate of Fire Compliance
 - (a) \$50.00 per certificate.

19) BLASTING PERMIT:

- (1) \$1,000.00 plus \$50.00 per day for each day of duration of permit.

20) VIOLATION SEARCH:

- (1) Residential Property Violation search:
 - (a) \$250.00 for each tax lot payable at time request is made.
- (2) Commercial Property Violation search:
 - (a) \$500.00 for each tax lot payable at the time request is made
- (3) \$50.00 for each re-inspection.

21) INSPECTIONS MADE BY VILLAGE ENGINEERING CONSULTANT.

- (1) Any inspection made by the Village Engineering Consultant that is not reimbursed by above fees, will be billed to the property affected on a cost basis, as evidenced by invoice submitted by the Village Engineering Consultant.
- (2) Annual fee of \$150.00 shall be required in connection with the review of Storm Water Pollution Prevention Plans.

22) PEDDLER'S LICENSE

- (1) \$45.00 per license.

23) PRIVATE SNOW REMOVAL CONTRACTOR'S PERMIT

- (1) \$25.00 annual fee.

24) FILMING

- (1) \$250 per day (filming on private property)
- (2) \$250 per hour (filming on public property)

25) FLOODPLAIN DEVELOPMENT PERMIT

- (1) \$250.00, In addition, the applicant shall be responsible for reimbursing the Village of Chestnut Ridge for any additional costs necessary for review, inspection and approval of this project. The Local Administrator may require a deposit of no more than \$500.00 to cover these additional costs.
