Checklist for New Construction / Alteration (s) – Commercial Construction:

- 1. Submit eight (8) complete packets of the following as well as electronic versions of all items listed below:
 - a. Application (1 original & 7 photocopies)
 - b. Narrative summary explaining the project and including any facts pertaining to this project which applicant feels may be of interest to the Board
 - c. Proposed topographic Plot Plan submitted with the building permit (8 photographs-not originals)
 - d. Complete full size Building plans that show the 4 exterior sides.
 - e. 11" x 17" floor plans for submittal & full-size floor plans for meeting & workshop.
 - f. Provide electronic versions of items listed above.
- 2. 20" x 30" Foam Poster Board with the following information:
 - a. Complete floor plans and color renderings (mounted on of all sides of proposed building, including elevations and landscape of proposed home.
 - b. Copy of filed Subdivision Plat
 - c. Name of the Subdivision as well as the Section, Block and Lot to be labeled in black at top of the board.
- 3. Required fees.
- 4. It would be preferable to the Board if the architect would appear at all meetings with the applicant.

Checklist FOR INDIVIDUAL LOT APPROVAL,

1. A 20"X 30" FOAM POSTER BOARD WITH THE FOLLOWING ATTACHED:

- a. Street facing elevation(s) of the dwelling, grade specific
- b. Photocopy of the proposed plot plan
- c. Color chips of all proposed materials.
- d. Spec Sheets on all proposed materials

e. Actual rendering or brochure picture of the proposed front door/sidelights (may attach one alternate door style also)

- f. 8¹/₂" x 11" copy of subdivision, highlight specific lot
- g. Name of subdivision and lot# in black at top of the board

h. Set of color photographs of all existing structures facing upon the same or intersecting street and withing 500' of the proposed new home. State on the reverse side of the photo the address of the structure and it's location in relation to the proposed home.

i. Provide electronic versions of items listed above.

- j. Complete full size Building plans that show the 4 exterior sides.
- k. 11" x 17" floor plans for submittal & full-size floor plans for meeting & workshop.
